Why “Beggar’s Night”?

“Beggar’s Night” in Des Moines is traditionally October 30th between 6 to 8 PM on the night before Halloween night. And, unlike everywhere else, the little goblins will tell bad jokes to earn their treats.

Local history has it that this tradition started in the 1930’s. Halloween had turned into a night of mischief such as soaping windows, ringing door bells, egging, turning over outhouses and dumping refuse in streets. But some youngsters tried to out-do what they had done the year before to include setting fires, theft and destruction of property. The chaos was getting out of hand and this became a huge problem for the police and a worry for all homeowners. Halloween had become more about thugs and vandalism than about costumes and candy.

The City’s Director of Recreation at that time was determined to turn that around and started a campaign to make Halloween into a night of innocent fun. The first thing was to proclaim “Beggar’s Night” on the night before Halloween and make the kids work for their treats. Apparently it took some time and the backing of community groups and members of law enforcement but she was successful. During World War II, the appeal to behave oneself on Beggar Night turned patriotic and children were admonished not to help the enemy by wasting resources and acting like saboteurs. “Beggars Night” is unique to Des Moines and it is not done like this anywhere else.

Welcome Beggar’s to your home by turning on your exterior lights.

Remove objects from your yard that might present a hazard to visitors.

Candy should be in original wrappers, if you choose to hand out candy.

Non-food items such as pencils, novelty pens or change are acceptable.

Homemade goodies and fruit is suspected by parents and often tossed.

Require the little Beggar’s perform for their treats, but above all, have fun with it.

Meeting Invitation

The Union Park Neighborhood Association holds a Spring and Fall General Meeting. Meetings start at 7:00 pm at Grand View University in the Humphrey Center (“Old Main”) on the 2nd floor. These are all open meetings and any neighborhood resident is welcome to attend. If you can’t make it to every meeting that’s ok but we would love to have you come whenever you can. Everyone’s input is welcome, whether you would like to help with a special event or project or just come to meet your neighbors. UPNA is accomplishing more each year so the more people that are involved the more good we can do!



Thanks to generous support from donors to Transformations: A Campaign For Grand View University, the building – an expansion and renovation of the GV Student Center -- will be completed in time for the start of the 2015 fall semester. Much of the building project will be funded by private gifts to the University.

The new Student Center will be 60,709 square feet, including 20,654 square feet of renovation to the existing student center and 40,055 square feet for a new two-story addition that will include a 156 foot skywalk over East 14th Street (Highway 69) connecting the Student Center to the Rasmussen Center for Community Advancement Professions. This skywalk will be the longest freestanding skywalk in the city of Des Moines.

The Student Center is the hub of student experience beyond the classroom. It houses Student Life offices, including student government, clubs and organizations, counseling services, multicultural programs, the Career Center, academic advising, and the Academic Enrichment Center. The first floor also will house offices and workspaces for the speech and theatre program and the Viking Theatre, as well as the classrooms, studios and offices of the Grand View Communication department, in addition to student lounges and recreation areas. The second floor of the new Student Center will be devoted to dining for students, faculty, staff, and visitors, with a lounge area adjacent to the skywalk.



The unique “Hjemad” sculpture by Mark Lamar (Class of 1980) which was placed in front of the former Student Center in 1996 was carefully removed for restoration and will be re-dedicated in another location on campus. In late November 2013, three of the uprights were damaged when a car veered from NE 14th Street and crashed into it. The metal sculpture is a stylized representation of the boats that Danish immigrants sailed in to America. It stands in a bed of river rock, depicting the ocean. It is dearly loved by many and we look forward to seeing it again on the Gvu campus in the future.

Cutting of Tree Limbs

On several occasions this year, UPNA has been asked for advice about how to handle trees that share property boundaries or reach over property lines. Neither UPNA nor the City gets involved in disputes between neighbors over trimming trees. It is considered a civil matter between two neighbors. We recommend neighbors talk to each other and work things out and come to a mutual agreement on how to handle situations rather than involve the legal system. However we have obtained a cheat sheet that may be useful as a guide.

Cutting of Tree Limbs:

The Law

Neighbors have the legal right to trim any hanging tree limb that crosses over their property line. However, neighbors may only cut the limb back to the property line and may not enter their neighbor's property for further cutting without permission.

Act of God

If one neighbor complains to the other that a tree limb is hanging over the property line and the tree-owning neighbor refuses to trim it, that neighbor can be held liable if the limb falls and causes property damage. However, if a tree limb crosses the property line during a natural disaster, such as a storm, and causes damage, the tree-owning neighbor will not be held liable. This is known as an Act of God.

Penalties

In the event that one neighbor does trim limbs that hang over her property line and, as a result, causes significant damage to the tree's health, the tree-owning neighbor may sue for damages. Courts may issue a settlement for up to three times the value of the tree. If the tree is historical or an ornamental tree, the settlement can be even higher.

Before any neighbor opts to trim any portion of a tree, he should first find out who legally owns the tree. Trees that rest on the boundary line between two properties are known as "boundary trees." Both neighbors have equal responsibility of maintaining this type of tree. If the majority of the trunk rests on one side of the property line, that neighbor has sole ownership.

Note that yes you can trim limbs that are on your side of the property line; but it is your responsibility to pay to have the limb waste removed, you cannot just throw them over the property line. Throwing the waste over the property line will allow your neighbor sue for damages.

With this information if you do not see a solution, contact you lawyer.

Are You Ready?

no cost to you) and send you \$50 for a qualifying refrigerator or freezer or \$25 for a qualifying room air conditioner.

Birdland Redevelopment Plan

The Birdland Redevelopment Plan is in the final stages. In 2008 an epic flood impacted a part of the Union Park Neighborhood Association area called Birdland. It is home to residential, commercial, industrial and recreational interests. After the 2008 flood, many homes in the Birdland area were bought out and removed and many businesses struggled to come back again. UPNA and others in the Parks Area pressed the Corps of Engineers hard to have the levee raised and strengthened. We were successful and now a new levee and floodgate protect the Birdland area. Now that the area is protected, the City of Des Moines, The Parks Area Foundation and citizens in Birdland area have come together to plan for the redevelopment of the area.

The Planning Committee was formed early this summer to prepare a redevelopment plan for the Birdland Area in Des Moines, Iowa. Jack Daugherty represented the UPNA Steering Committee on the Planning Committee. The boundaries of the Birdland Area are area bounded by the Levee on the south, Saylor Road on East, Sheridan on north, and Second Avenue on west.

The goal and the challenge of the planning committee was to develop a community consensus on the outcomes that are most desirable and feasible, and create a vision and plan to be used by developers and decision-makers as a guide for future development and redevelopment of the Birdland Area.

During the Planning Process, an Area Specific Plan was developed that focused on what land uses are most appropriate – residential, commercial, industrial, mixed use, open space, etc.; recommendations on design and building forms that will compliment the surrounding neighborhood; how these uses and design forms best transition to the surrounding uses; analysis of existing infrastructure conditions; and recommendations for infrastructure upgrades necessary to support future development.

The City of Des Moines City Council and Neighborhood Revitalization Board (NRB) allocated Community Development Block Grant (CDBG) funds to complete this redevelopment plan. The City of Des Moines is partnered with the Parks Area Foundation and other area

neighborhood associations to undertake this important planning effort for the Birdland Area.

The fifth planning meeting was on September 23rd. On October 7th, the second public meeting for the Birdland Plan was held at the Ding Darling Shelter at Birdland Park. The draft plan was presented and final input was taken at this meeting. The next step is to finalize the plan and begin the approval process. On November 4th, the Parks Area foundation will review the final plan at a special meeting. Then they will forward it to UPNA for review so we can approve or comment on it at our November 11th meeting. After that, it goes to the Urban Design Review Board, P&Z and finally to City Council for adoption as an amendment to the Des Moines' 2020 Community Character Plan.


